Council on Anthropology and Education Annual Report 2024 *Transitions* Tampa, Florida November 20 - 23, 2024

Board of Directors Reports Executive Committee Reports

President, Denni Blum

Carrying forward the good work of my predecessors, I was committed to providing leadership that supported CAE's mission and vision and that built capacity for CAE to be a responsive and engaging organization. These intentions helped provide structure to weekly tasks and considerations throughout the year. Here are some highlights.

Carrying forward the good work:

- The President hosts monthly meetings with the CAE Officers of the Council and Executive Committee. We alternated months so that the larger Officers group had fewer meetings to attend. We continued the model of having a google doc agenda for each meeting, which allowed each person to add agenda items and notes prior to the meeting, helping with using our time efficiently.
- I utilized our various communication channels to keep in touch with CAE membership. Although I didn't send out communications on a predictable, regular schedule, I tried to do this at least once every couple of months. These were sent via the CAE Google listsery, CAE Facebook page, and the AAA Communities tool.
 - The Executive Committee supported the AEQ editorial team in the journal's transition, as AAA introduced a new contract with Wiley, transitioning from ScholarOne to Research Exchange (REX), Wiley's proprietary submission platform (Jan-March) and with changes to some of the editorial duties.
- The CAE logo submissions were voted on during Angelina's presidency, but the Executive Committee did not seem completely satisfied the logo options. The future president may want to ask the MAL to continue to solicit submissions or go back to the logo considered during Angelina's presidency and decide how to modify/use it.
- The President is tasked with attending monthly meetings for all AAA Section Presidents. I shared my notes about important issues emerging in these meetings with the CAE community. Examples of issues that were discussed in the AAA Section President meetings include concern over the 2024 Annual Meeting location (safety for BIPOC and LGBTQIA+ attendees), AAA membership trends, the AAA boycott of Israeli academic institutions, and sociopolitical statements. CAE Officers of the Council wants AAA to waive the registration fee for international members. I contacted the corresponding leaders to have this put on the Presidents' section meeting agenda and I also inquired about it during our Presidents' section meetings. I was told that this would be addressed in the next meeting, yet each meeting it was put off and never addressed.

Providing Leadership for CAE's Mission and Vision:

• In an effort to both connect and support members throughout the year and showcase the good work that CAE members are doing, we have been circulating virtual events through our CAE

- Facebook page and CAE Google listsery. In the future, we will want to consider also having "CAE Affiliated Events." These can be events that are already going on at members' institutions. Once shared with us, CAE is willing to be a co-sponsor and promote the event through social media.
- To support more early career scholars, the Executive Committee worked to allocate additional funds to this important goal. We were able to give more money than previous years to our Shirley Bryce Heath awardees, and we also initiated moving some of our savings into endowments to ensure sustainability of these higher awards, specifically to fund international scholars who are presenting at AAA. I also began conversations with the Executive Committee about setting aside funds to support CAE leaders to attend the Annual Meeting.
- We did not have an Outstanding Dissertation Award in 2024. As a result, the Executive Committee voted to extend the timeframe that one is qualified to be a nominee. The nominee has to have earned their PhD within the last 4 years (instead of 3 years), and CAE is open to awarding two Outstanding Dissertation Awards (instead of only one) in 2025.
- In the spirit of expanding collaborative projects and spaces for scholarly work, Angelina and I partnered with the Royal Anthropology Institute in London to plan for a conference that took place in June 2024 on anthropology and education. CAE was one of the sponsors of this event, and I shared information with membership about the conference and ways to get involved.
- As part of CAE's mission to "advance anti-oppressive," and "racially just solutions to educational problems," CAE published (I drafted and solicited review and input from the Executive Committee and Thea Abu El-Haj) a statement regarding genocidal and "scholasticidal" violence in Gaza.

Building CAE Capacity:

- I am grateful that Angelina initiated the charge for each officer to create a handbook for each position that is updated annually by the person in that position. This made everyone's job easier.
- I reminded CAE Officers to ensure handbooks were updated for future officers. This is an important effort to build and maintain our infrastructure as an organization.
- I continued to support the transparent process for the identification, nomination, and selection of future CAE leaders that Angelina started. This information was sent out to all members and will hopefully provide a template for future years.
- This was the first year to use "Interest Groups" instead of "Committees." This is an area that has potential to grow our membership and provide a stronger sense of community. Hopefully, the President can continue to provide guidance.
- CAE membership has had a slow decline in membership over the years. Of most concern is student membership. Hopefully, with more virtual initiatives from Interest Groups, the membership can grow.

President Elect and Program Chair, Char Ullman

Throughout this year, we have continued to transition to more in-person engagement, along with virtual options, to connect our members with each other and to share in knowledge production.

CAE at AERA

AERA was held April 11-14, in Philadelphia. We created a flier with the titles of CAE members' presentations and distributed it both through the CAE Facebook page, google groups listsery, Instagram, and AAA Communities listsery. 30 CAE members presented at AERA this year. We advertised the CAE breakfast through these same means (see above), along with announcements by CAE members in the AERA Div. G. network. We hosted a breakfast reception at the Downhome Diner, near the convention center. There were approximately 25 attendees, plus two CAE board members at the breakfast (Angelina Castagno and Eulalia Gallegos Buitron).

AAA 2024 Annual Meeting: CAE received 40 submissions for this year's annual meeting. In addition to the scholarly sessions, CAE hosted eight Special Events at the Annual Meeting. These Special Events ranged from intimate gatherings for mentoring to celebratory receptions.

AAA stopped allowing individual paper submissions this year, which saved me from having to create panels out of individually submitted papers, as Denni Blum had to do last year. There were more virtual options to present this year, along with roundtables, and the traditional inperson panels. This year, we were able to have the CAE poster presentations become part of the larger AAA poster session.

I look forward to hearing from CAE membership and Board Members about their experiences at the annual meeting, so that we can use this to inform future work.

Succession Planning and Three Highlights of the 2024 Meeting in Tampa

The CAE Handbook was helpful, as was being able to reach out to the previous year's Program Chair and current president, Denni Blum. I also received valuable trainings and advice from Amaris Morningstar, who is staff at the AAA. I will provide updates on the CAE Handbook for the incoming President-Elect and Program Chair after the 2024 meeting. Despite the recent hurricanes and tornados that have ravaged Tampa this fall, we appear to be ready for the annual meeting of the AAA. Below, I am highlighting three events that are a bit different this year: the Community Engagement event, the Students of Color/LGBTQ+ Mentoring Event, and the CAE Past President's Distinguished Lecture.

1. Community Engagement Event and Town Hall

Current Movements to Advance Activism and Solidarity in Tampa Bay
We will work with local organizations advocating on behalf of LGBTQ, Immigrant,
youth/education, and African American communities in/around Tampa. We will curate a panel
of local activists, working for justice in their communities, to share their work and offer our
solidarity. Given the conference theme (Praxis), the panel will enhance participants'
understandings of critically informed local action for justice. We will align our event so that
participants can also visit the exhibits at the History Center, including one related to Black
History in the region. We hope to invite the Columbia Cafe - onsite at the History Center, and a
local longtime community restaurant - to cater the event. We'll invite attendees to
support community efforts through a donation drive during the event. Our event will engage
local community members and enrich the annual meeting by providing conference goers with
opportunity to learn from and support local activist groups. This year, we combined the
community event and the town hall, which will be held on the last day of the conference
(Saturday). This event was made possible through the tireless work of Sarah Newcomer, Eulalia
Gallegos-Buitron, Deb Palmer, and Molly Hamm-Rodriguez.

2. Students of Color/LGBTQ+ Mentoring Session

The executive board decided to host the Students of Color/LGBTQ+ Mentoring session off site on Thursday evening, from 7:30-9:30 PM. We were able to put in the program that participants should go to the lobby and look for a sign to meet up for the event, because at the time, we did not know where we would plan to hold this event. Since then, I was able to reach out to Molly Hamm-Rodriguez, who told me this:

I would recommend <u>Sparkman Wharf</u>. It is an outdoor, waterfront area with a lot of different food and drink options. The only potential challenge is that it closes at 9pm on Thursdays. You can walk to it (about 11 minutes) or there is a free trolley.

Thanks so much to Molly Hamm-Rodriguez for recommending this venue. Our CAE graduate student representative, Andrea Vazquez, whom we thought would host this mentoring session, did not respond to our messages. Later, we learned, thanks to Carla McNelly, that she is no longer a student, and currently holds an academic position. As a result, I (Char Ullman) will host the mentoring event, along with (potentially) a student of Angelina Castagno's, provided they are able to obtain departmental travel funds.

3. CAE Past President's Distinguished Lecture

Budget Notes

Brief description of 2024 activities to CONTINUE into 2025:

- The CAE Executive Committee modified membership dues for two categories:
 - 1. Retired Members: Dues were reduced from \$50 to \$25.
 - 2. International Members: This is a *new* category for CAE members. The dues for this category are \$0. This decision was made in order to encourage more global membership by reducing financial burden.
- In addition to our normal AAA meeting activities/expenditures, we will continue to support CAE members through our annual Awards Program: Presidential Fellowship (Gaitan), Outstanding Dissertation (Erikson), Young Scholar Travel Support (Brice Heath), and Outstanding Career (Spindler --this award pays for itself through the endowment).

- o In 2023, we increased our Shirley Brice Heath Travel Award quasi-endowment by \$25,000. In 2024, we have moved forward in distributing this new amount of award money and will do so here on out. The award yields \$1,600 in interest and the CAE will supplement the award from here on with \$1,600 from the general budget for a total of \$3,400 to be given in travel award money. This will provide 6-8 awards between \$400 \$550.
- o In 2024, the CAE Executive Committee established the CAE International Travel Award and voted to invest \$25,000 in the initial investment for this award. The award will yield 4% interest rate, guaranteeing an award of \$1,000 to an international CAE member. The CAE Fundraising Committee will fundraise with membership to increase the base of this award. Any additional money raised will support an international member's travel to the annual conference. Paperwork to establish the award and transfer the initial funds will be processed in late 2024/early 2025.
- In 2024, the Erickson Dissertation Award was not awarded. It was agreed that in 2025 two dissertation awards will be given at \$500 each, for a total of \$1,000 from this account.
- We will also continue our current Promotion & Development events --we will continue to
 promote CAE and recruit new member by hosting an annual CAE breakfast event at AERA.
 We will also continue to pay for Later Social Media Marketing Platform to plan for and
 enhance communication across social media sites.
- We will continue to operate with the followed agreed upon budget decisions from 2023:
 - o Meeting Food and Space Budget (\$3,800) will be broken down in two parts: 1) \$3,500 for the Business Meeting and 2) \$300 for the Presidential Fellows Reception.
 - o \$2,000 annual stipend for the Communications Coordinator.
 - o \$500 will continue to be allotted for the award trophies.
 - o \$500 will continue to be allotted for the *President's Discretion* funds.

<u>Description of CHANGES PLANNED for 2025:</u>

- One budget area that CAE is consistently underspending in is *Development and Promotion*. Leadership has decided to host the annual AERA breakfast event off-site (not in the conference hotel) and has saved a considerable amount of money. This has freed up approximately \$1,000 \$1,300. In 2024, the remaining money from this account was used to support the combined CAE Town Hall and Community Event and to supplement the Shirley Brice Heath Travel Awards. In 2025, CAE leadership will continue to discuss and track best uses of these funds.
- A major budget change in 2025 will be implementing the aforementioned investment in a
 new award, the CAE International Travel Award. This transfer of funds will be an investment
 in our international membership and will function to broaden our reach and impact as a
 section. Once we have confirmation from the AAA that we are able to give the award, we
 will move forward with selecting a recipient. Our Fundraising Committee will continue to
 fundraise to increase the amount of the award.
- The CAE Executive Committee has agreed to establish a CAE Leadership Travel Award. This award would support those in CAE leadership positions that are volunteering their labor to the CAE but not receiving financial support to attend the annual conference. The establishment of this award would help to ensure a strong presence of CAE leadership at the

- annual conference to enhance overall investment in the section. Details of this award, including eligibility and selection criteria/committee, will be determined in Spring 2025.
- Given the changes to in publishing of *Anthropology and Education Quarterly (AEQ)* under new contract with Wiley, the budget for the journal has decreased over the past three years. Luckily, the current editorial team is being supported by their institution and are not requiring the use of the full AEQ budget. Current expenses include support for editor and student assistant travel to the conference. The Treasure has been tracking the how of much of the AEQ budget is not being spent so as to earmark it for future use. The CAE wants to support high quality editors and we anticipate that future editors may not have as much institutional support. Current unused funds will be used to support future editorial needs.
- The AAA Controller has modified budget documents to be more streamlined and use the same object codes to track spending that AAA uses. Moving forward, the numbers in the annual report will reflect that format (see the 2025 Budget table for an example). This will help ensure the orderly record keeping of CAE budget documents and reduce labor for the Treasurer.

END OF TREASURER REPORT

Communication Coordinator, Jess Sierk

Since November 1, 2023, I have posted 49 times on Instagram. We presently have 254 followers on the platform, a 39% increase from this time last year. Our posts reached an average of 76 people, 89% of whom were followers of our account. On average, eight people interacted with each post, meaning they liked, saved, commented, or shared it. On average, four people engaged with our profile from each post, meaning they visited, clicked on our link in bio, or followed our account after seeing a post. On Facebook, we currently have 712 group members, a nine percent increase from this time last year. One change I have implemented on our Facebook is the addition of membership questions. When someone goes to join our page, they are asked three questions:

- What interests you about anthropology and/or education? (open-ended)
- What do you hope to gain from joining this group? (open-ended)
- Are you a member of AAA and CAE? (possible responses: yes, both; yes, AAA but not CAE; not currently, but I have been a member before; no, but I'm interested in becoming one; no)

The purpose of these questions is twofold. First, it protects our account from fake accounts and bots. Secondly, the responses can provide feedback about new followers that might help us grow our membership. In the past year, 367 group members have been active (meaning they viewed, posted, commented, or reacted to content on our page), a three percent increase from last year. I look forward to continuing to attract more of our membership to join us on these platforms.

Other tasks I have engaged in over this first year include, but are not limited to, updating our website (e.g., adding an archive of past presidential addresses), continuing to hone our social media schedule and post templates, meeting with other officers and members interested in getting the word out about events and opportunities, answering and redirecting responses to our volunteer poll on the website, fielding emails, and generally assisting with other CAE tasks. In the upcoming year, I plan on continuing to work on the handbook for this position. *END OF COMMUNICATION COORDINATOR REPORT*

Officers of the Council Reports

Third Year Member at Large, Cathy Amanti MAL Year 3, Cathy Amanti

This report concludes my eight years of service to the Council on Anthropology and Education (CAE). I served two terms as contributing editor for CAE to Anthropology News and the past three years as Member at Large (MAL). My first year as Member at Large overlapped with my final year serving as contributing editor to Anthropology News. I believe my two greatest contributions to CAE have been collaborating with Carla McNelly to revamp our website and, assisted by Carla McNelly, Reva Jaffe-Walter, and Deb Palmer, reformatting the MAL handbook and MAL Google folders. A special thanks to Carla for taking care of the technology aspects of the website and MAL handbook/folders. I also successfully petitioned the executive board to lower the annual dues for retired members and eliminate dues for international members. The reason for the latter is that the American Anthropological Association (AAA) has a narrow and discriminatory definition of international membership based on the World Bank category of Least Developed Country. I also asked that we urge AAA to broaden the definition of international member to include anyone who is a resident of any country other than the United States and lower the dues for international members. The AAA is enriched by its international members. International members face higher travel expenses to attend annual meetings. Some also face additional barriers such as securing visas.

The tasks I completed that were my responsibility as third year Member at Large this year include:

<u>CAE Election</u> – Submit names and bios of CAE candidates for elected positions to AAA for inclusion on AAA spring ballot. Lesley Bartlett was elected incoming president and Vanessa Anthony-Stevens was elected incoming Member at Large.

<u>2024 Awards</u> – In January I organized a small committee to help me identify potential chairs for the 2024 Foley, Spindler, Erickson, and Outstanding Book Awards committees. Committee members included Carla McNelly, Meredith McConnichie, and Angelina Castagno. In February, after confirming chairs for each committee and developing detailed guidelines with deadlines, I met virtually with all award committee chairs to review the guidelines and answer questions. Chairs were asked to complete their work and submit names of their award winners by mid-September. I also helped chairs identify potential committee members as needed. I checked in with committee chairs periodically with deadline reminders.

It was a challenging year for awards work. Initially, there was only one nomination for the Spindler Award (Chair, Sarah Roberts). The committee did not feel that the one person nominated met award requirements. Even though it was early September, the committee elected to repost the call for Spindler Award nominees and was successful in soliciting more nominees and selecting a deserving winner. Work on the Erickson award got behind schedule and, when work had not begun to review nominations by early October, it was decided not to give the award this year due to the short amount of time it would have given the committee to carefully review nominated dissertations. In addition to Sarah, thank you to Rosemary Henze (Chair, Foley Award) and Daniel Heiman (Chair, Outstanding Book Award) for their leadership and commitment to honoring CAE members.

Nominating Committee for Elected and Appointed Positions – In the spring I formed a committee to help prepare materials and review nominees for appointed positions (starting in November 2024) and elected positions (starting in 2025). The committee consisted of Eulalia Gallegos, Carla McNelly, and Sofia Villegas. A nomination form for all open positions was circulated in July and early August. In early August, the committee hosted a virtual information session for anyone interested in a CAE leadership position. Peter Demerath joined the information session to talk about his experience as CAE president. Once the nomination deadline passed, the committee met to review the nominations. There were seven people who self-nominated. There was one or more nominee for every open position except president and all submitted nominees were placed in a position. The committee unanimously agreed to invite Eric Johnson to be a candidate for president to take office in November 2025, which he accepted. He, along with MAL candidates Michelle Bellino and Thierry Elin-Saintine, will appear on the spring 2025 AAA ballot.

Meet with other Members at Large – For the past two years, CAE MALs have met periodically to give each other updates and to support each other. These have been extremely helpful as each year, MAL tasks change. A final responsibility of mine has been to remind the other MALs to update their section of the MAL handbook and place all of the documents they have used and created in their folders in Google Drive. We want to make the work of future MALs simpler and easier going forward.

<u>Douglas Foley Early Career Award 2024</u> Rosemary Henze (Chair)

This year the committee for the award consisted of Rosemary Henze (chair), Peter Demerath, Sarah Gallo, and Jen Stacy. The committee received seven applications and, after careful deliberation, selected Sophia Rodriguez as the winner, with runners up Jennifer O'Donnell and Sally Bonet. (submitted by Rosemary Henze)

George and Louise Spindler Award 2024 Sarah Robert (Chair)

This year the committee for the award consisted of Sarah Robert (Chair), Bryan Brayboy, Jennifer Sandler, Michelle Bellino, and Holly E. Marcolina (graduate student). There were four nominations received. Thea Abu El-Haj was selected as the winner. Based on the committee's experience, Sarah Robert recommended that self-nominations not be allowed and that nomination letters with multiple signatories should be encouraged.

Outstanding Book Award 2024 Dan Heiman (Chair)

Second Year Member at Large, Deborah Palmer

<u>TASK</u>: Inviting Posters for Annual Meeting (formerly New Scholar Poster Session)
A few weeks before proposals were due for the Annual Meetings in Tampa (in April 2024), I reached out to Char Ullman (incoming President) because I had heard that she wanted to see the New Scholar Poster Session merged with the AAA Meetings Poster Sessions in order to improve visibility for our new scholars and streamline processes. We decided to merge the poster session with the regular submissions process and to accept posters to participate in the general AAA poster sessions (which, in 2024, will be scheduled at times that do not conflict with other sessions). In 2024, posters were the only way to be accepted to present as a solo paper (ie. not part of a session). We advertised them as such - we created a flyer and reached out to the CAE community of junior scholars encouraging poster submissions.

Eight posters will represent CAE as part of the AAA Meetings Poster Session on Thursday evening November 21, 2024. This is double the number who participated in last year's separate poster session, and we anticipate they will also receive increased attention given AAA's efforts to ensure attendance (e.g., holding a happy hour at the session, not having any conflicting events).

TASK: Shirley Brice Heath New CAE Scholar Travel Stipend

In summer, with help from Jess Sierk (before her babies were born!) I publicized the SB Heath Travel Stipends to all New CAE Scholars who would be presenting at the Annual Meetings in Tampa (in person). I then invited/convened a committee - Suzanne García (Associate Professor, CSU Monterey Bay) and Huseyin Uysal (a CAE new scholar who volunteered to serve). Jen informed us we would have \$3200 to distribute. Using a google form and subsequently a spreadsheet to map candidates' qualifications against the Award Criteria, we were able to accept 8 New Scholars who would be presenting in person in Tampa. Each winner will receive \$400 toward their trip expenses. I collected head shots/bios and connected them with Jen for the conveyance of funds.

<u>TASK</u>: Work with other members of the membership committee. There was discussion at the Officers of the Council meetings regarding this committee's mission, but we have not yet taken action; the membership committee has been relatively dormant this year.

However, I have been working with 1st year MAL Sarah Newcomer and USF (Tampa Bay) colleague Molly Hamm-Rodriguez to put together a Community Event/Town Hall at the upcoming Tampa Meetings that will include local teachers and four activists involved in human/civil rights struggles in Florida. The event will happen at the Tampa Bay History Center, and will include light refreshments and an opportunity to view exhibits related to African

AEQ features articles based on views from/on the field and

reflections on doing ethnography. AEQ provides an outlet for ethnographic short fiction, poetry, and creative non-fiction to be featured in the creative section of the journal. In addition, the journal welcomes submissions of reviews of published books that come from a wide range of relevant topics in anthropology and education.

AEQ also reviews proposals for special themed issues. Before submitting a prospectus, please email the editors directly to inquire about your special issue idea. If invited, prospective guest editors for special issues will then submit a prospectus that includes a detailed description of the overall theme, titles, author information, and abstracts for all papers to be included. The prospectus may be sent to the editorial office at anthroedquarterly@gmail.com. Papers submitted to AEQ as part of a special issue undergo the same rigorous review process as do regular submissions to the journal. More about our four article types:

Original Article (35 double-spaced manuscript pages)

Anthropology & Education Quarterly is a peer-reviewed journal that draws on anthropological theories and methods to examine educational processes in and out of schools, in US and international contexts. Articles rely primarily on ethnographic research to address immediate problems of practice as well as broad theoretical questions. The manuscript (formatted as a Word document and blinded for anonymous peer review) should be no more than 35 pages in length.

From the Field (15-20 double-spaced manuscript pages)

From the Field are short pieces on fieldwork and teaching experiences. Reflections on the Field are concise pieces on key figures and moments. In both cases, reflections pieces should have field-shaping implications for educational anthropology. Note that articles on the teaching of anthropology normally do not fall within the scope of the journal. The manuscript (formatted as a Word document and blinded for anonymous peer review) should be no more than 15-20 pages in length.

Creative Manuscript (5,000 words)

The Creative section publishes pieces that creatively use and represent ethnographic data. Most of our work as ethnographers results in the formulaic presentation of data and research in an academic journal article and/or a conference presentation. In this section, we challenge ourselves to re-imagine our data into different formats. How can ethnographic data tell a story beyond the "thick description" of an article? Might the data tell the story better as a short vignette? A poem? A letter? A cartoon? Think about the author Zora Neale Hurston, a trained anthropologist who used her ethnographic data to write novels such as *Their Eyes Were Watching God*.

Book Review (600-900 words)

Anthropology & Education Quarterly book reviews provide readers with a timely guide to newly published literature on learning and schooling in cultural and social context and are typically 700-900 words in length. The list of available books for review is on our website. AEQ welcomes scholars to contact us at AnthroEdQuarterlyBookReview@gmail.com if they would be interested in reviewing one of our available books for review. We ask that potential reviewers request only one book at a time. Reviewers should be "arm's length" from the author(s) of the book. "Arm's length" means that reviewers should not be predisposed to view the work either positively or negatively. They should not have a relationship with the author nor with the author's advisor. Reviewers cannot be close friends, current or recent collaborators, former

supervisors, advisors, or colleagues in the same department. Arm's length does *not* mean that the reviewer must never have met nor heard of the author(s). By submitting a book review, you attest that you are "arm's length" from the author(s).

AEQ also reviews proposals for special themed issues. Before submitting a prospectus, please email the editors directly to inquire about your special issue idea. If invited, prospective guest editors for special issues will then submit a prospectus that includes a detailed description of the overall theme, titles, author information, and abstracts for all papers to be included. Papers submitted to AEQ as part of a special issue undergo the same rigorous review process as do regular submissions to the journal.





In 2023, AEQ received 153 manuscripts. 116 were new/original/distinct manuscripts; 37 were revised versions of 2022 and 2023 papers.

*The total number processed is interesting because it more accurately reflects how much labor is involved. In 2023 we received 116 distinct manuscripts, but because some were encouraged to revise, that meant there were 153 times that manuscripts had to be reviewed by 2-3 reviewers, managed by an AE, and have a decision letter written by an EIC.


Acceptance Rate:







Fundraising Updates:

• The CAE Executive Committee voted to approve the International Travel Award. The aim of this award will be to offset the costs for selected international CAE members located outside of the U.S. and Canada who will be presenting in-person at the annual AAA meeting. - As a committee we are planning an annual fundraising event for this award during the AAA meeting that will bring together the CAE community.
- There are currently 3 members of the Fundraising Committee: Sarah Gallo (Chair), Sonia Chinn, and Chandler Miranda.

END OF FUND RAISING REPORT

Anthropology News, Tricia Niesz, Contributing Editor

The CAE Contributing Editor to AAA's *Anthropology News (AN)* solicits, edits, and shepherds four CAE-sponsored contributions each year (one per quarter) for publication on the *AN* website.

This was my second year of a three-year term in this role.

The following CAE articles have been developed and published in AN over the last year:

I have continued to work with Jessica Sierk, who promotes our *AN* articles through CAE's social media channels. I have also shared all of these articles through both of our CAE listservs (Communities and google groups).

AN experienced editorial changes again this year, but the personnel turnover seems to have stabilized. However, the new editorial team made a major change in Section contributions to *AN*. Here is how the AN editorial team explained the change to the Section editors:

"At the beginning of this year, we moved away from print AN issues, instead publishing only on the website. Our plan now is to move away from 'issues' entirely and instead have thematic 'open calls.' We would open a window (say, two to four months) where we would accept submissions on a specific topic and then publish any accepted pieces on a rolling basis (though these would eventually be compiled under the theme on our website, much like issues are now). This would help us have a more continuous flow of content on the website, spread out the editorial workload, and allow us to initiate calls for relevant topics quicker than would be possible with an issue-based process. We could even launch quick-response calls, perhaps with a shorter submission window, to respond to particularly time-sensitive events, or have occasional themes with guest editors. To complement this change, we ask that moving forward you solicit section pieces based on these thematic calls (and only those themes), which we will let you know about in

advance. We feel that integrating section pieces into the AN themes will provide more cohesive (and yet still diverse) content and a stronger identity for AN."

In response to this major change, I have shared upcoming AN themes with the CAE membership via our two listservs. I have called for abstract-length proposals for upcoming theme issues. These have been and will continue to be reviewed by a small committee to select the CAE contribution for each themed issue. Our first of these, based on the theme of "care," is currently in progress and will be submitted around November 1, 2024. Kathryn Wright was selected as the author; her in-progress piece is currently titled, "Capacity for care: Disabled worlds of care in middle-school classrooms." Abstract proposals for the second theme, "migration," are currently in review.
